TABLED MATTERS:

1. **CARPORT: *TABLED TO JANUARY 13th, 2026 MEETING*** Located at 438 McEwen Drive. Applicant Lisa McBride is requesting **AREA VARIANCES** to allow a front setback of 0ft for a carport where 50ft is required and a front setback of 20ft for a deck where 50ft is required, associated with an existing carport and deck on a 0.41-acre parcel having SBL# 093.06-1-27 located in the R-3 Single-Family Residential District under Sections 350-12 and 350-36 and 350-38 of the Code of the Town of Webster.
2. **SHED:** Located at 1140 Brooktree Lane. Applicant Bryan Weise is requesting an **AREA VARIANCE** to allow a shed in the front yard of a corner lot which is not permitted, located on a 0.4-acre parcel having SBL# 065.05-1-99 located in the R-1 Single Family Residential District under Sections 350-10 and 350-47 of the Code of the Town of Webster.

1. **ACCESSORY BUILDING: *TABLED TO JANUARY 13th, MEETING** Located at 671 Willow Lane. Applicant Bryan Bischooping is requesting **AREA VARIANCES** to allow side and rear yard setbacks less than what is required, and to locate the building closer to the front wall-plane than the rear wall of the main building associated with the construction of a 500 SF detached accessory building on a 0.46-acre corner lot parcel having SBL# 065.13-2-11 located in an R-3 Single Family Residential District under Sections 350-12 and 350-36 of the Code of the Town of Webster.
