Applicant Lisa McBride is requesting <b>AREA VARIANCES</b> to allow a front setback of 0ft for a carport where 50ft is required and a front setback of 20ft for a deck where 50ft is required, associated with an existing carport and deck on a 0.41-acre parcel having SBL# 093.06-1-27 located in the R-3 Single-Family Residential District under Sections 350-12 and 350-38 of the Code of the Town of Webster.	<b>APPLICATION Tabled UNTIL MARCH 10<sup>th</sup>, 2026, MEETING</b>	<b>5-0</b>
