**THE CONTRACT IS CHANGED AS FOLLOWS:**

Change Order 10 Consist of 4 parts as follows.

**10 A** - Due to the condition of the existing storm sewer. Portions of the sewer were unable to be saved and therefore needed replacing. CO10A proposes to increase the quantity of Storm sewer installed by 123 lf. Pay for 50 lf of 18" HDPE and incres the number of storm inlets replaced by 1.

**10 B** - During storm sewer removal, 15 storm laterals were encountered that required replacing with conneciton to the new storm. These will be paid out on a per each cost provided by Morsch. See attached.

**10 C** - Given the configuration of Manhole S-14, the lateral connecting for the School needs to be raised to avoid adverse effects to the School. 12" PVC will be installed at a lesser slope to chase grade and tie into the existing 8" sanitary later. The sanitary work will be completed by Morsch and paid for using existing contract pay items for 18" PVC sewer (12" installed), trench excavation, and restoration. A quantity of 150 lf is estimated for replacement. The quantity installed will be paid.

**10 D** - Under Change Order #7, All fees paid to Paradigm Enviroental by the Town of Webster, are to be credited to the contract. Only Fees after Manhole S4 are to be credited 57 days at \$690 per day.
