

2026 Webster Budget Message

The Town of Webster commenced the 2026 budget season in early May. It's a process that takes six months of the year to complete and it demands a considerable effort by the Town department heads, the Director of Finance and the Town Board. Each department head was instructed to put forth their best effort to minimize the tax levy for the citizens, while providing for the needs within their respective departments. The department heads presented their budgets during the live streamed budget workshops that were held on July 31 and August 7. A public hearing on the 2026 Preliminary Budget will be held on October 16 at 7:30pm.

Since the Town's primary role is to provide services, employee compensation and benefits is the largest portion of the budget. It encompasses 55.4% of net expenditures. Total employee compensation for 2026 is \$17,055,499 versus \$16,377,353 for 2025. This represents a \$678,146 (4.2%) increase. Two new positions were added, which include an assistant assessor and an engineering technician. The two positions have an aggregate compensation cost of \$130,883. However, the cost is partially offset by two part time positions that will not be funded within the 2026 budget.

The employee benefits include contributions to the NYS retirement system, employers share of social security, worker's compensation insurance, medical and dental insurance, health savings account contributions and medical insurance paid on behalf of retired former employees. The budget for 2026 is

\$9,728,100 versus \$8,407,000 for 2025. The 15.8% increase is due mainly to a rise in base wages and escalated NYS Retirement System contribution rates as well as a sharp increase in retiree health insurance costs for Medicare supplemental health insurance.

The 2026 budget includes a significant increase in debt service costs. In August of 2025 the Town renewed the 2024 bond anticipation note (BAN) and issued a serial bond. The borrowing totaled \$101,141,000 to fund the Highway Building project (\$24,250,000), Sandbar Park project (\$3,706,000), the Wastewater Treatment Plant Phase II project (\$66,400,000), the Vosburg Pump Station project (\$380,000) and a serial bond for the Tebor to Phillips Road Conveyance Pipe project (\$6,405,000). The BAN is a one-year loan which is based on projected cash flow requirements for each project. The Town's debt sale was very competitive, which resulted in a \$1,276,292 premium paid to the Town and a net interest rate of 2.6662% on the BAN and 4.4529% on the bond. This is thanks to the Town's excellent Aa1 bond rating. When the BAN matures the premium will be recognized as revenue in 2026 which will partially offset the gross interest charge. The bond will be repaid in 9 years and will be reimbursed by Coca Cola fairlife at a rate of 96%. The Town's net debt service payments for 2026 will total \$6,230,728 versus \$5,271,174 for 2025. This represents a \$959,554 (18.2%) increase.

This budget includes increased wastewater treatment revenue

wastewater treatment revenue from commercial sewer charges and fees for treating high strength organic waste. The two categories are up an aggregate of \$1,935,472 (179.4%) year to year. Even though debt service cost has increased substantially within the Sewer Fund the revenue generated from the wastewater treatment business has outpaced the cost by \$2,460,091 (97.2%) during the past three years.

A large portion of the Town's surplus fund balance (\$6,008,158) has been appropriated to stabilize the 2026 tax levy. The appropriation helps the Town stay in line with its' fund balance policy which has set limits on the amount of surplus that can be held. An average home outside the Village has a \$178,000 assessed value. If it is connected to the sewer system, the aggregate tax bill for an average home outside of the Village of Webster will go up \$28.84 or 2.4%.

Overall, the 2026 budget is fiscally sound even though there is increased debt related to the various capital projects that are in process. The additional costs have been offset by increased revenue and the utilization of surplus funds to stabilize the tax rates. As always, the Town officials are working together to project the Town's financial position into the future so that revenue and expenses can be effectively managed beyond the one-year window of the budget process. We are pleased to say that the Town has been able to stay under the New York State tax cap, while continuing to provide the same level of service to the citizens.

2027 REVALUATION PROJECT:

How to prepare for 2027... today

The Town of Webster is entering into its first townwide revaluation, or reassessment, project in over twenty years. Revaluations are so often met with skepticism, misunderstanding, and anxiety; however, this is usually unnecessary. The Town is committed to working with the community throughout this process to help overcome any fears and ensure this process is as smooth as possible.

While the results of the Revaluation project will not be seen until about two years from now in 2027, there are still ways to prepare for the future... starting now!

Familiarize yourself

One of the best ways to prepare for the 2027 revaluation is to familiarize yourself with terminology, your current assessment, and the current real estate market. Key terms and their definitions can be found on our revaluation webpage, under resources.

Today's market includes the sale that will be used to value all properties in 2027. Even a casual review of the market from time to time can help you become familiar with where the Webster real estate market is today.

This may help lessen the "sticker shock" of a revaluation. There are

several online sites that can be helpful in finding properties similar to yours and their selling prices.

The aim is to put your new assessment in line with the market. The sale date period to be used is July 1, 2023, through June 30, 2026. Sales with unusual circumstances, such as foreclosures, death of an owner, divorce-forced sales, etc. will not be used for this project.

Review exemptions

If you missed our Exemption and Inventory Workshop on September 25, there is still time to review the exemptions, or discounts, you are eligible to receive on your school and/or property tax bills.

Exemptions are available for permanently disabled persons, seniors, veterans, clergy, volunteer firefighters and ambulance workers, and for new construction on business projects. The application and qualification deadline to affect September 2026 school tax bill and future tax bills is March 1, 2026.

Verify the inventory

The final way to prepare for the upcoming 2027 Revaluation is to verify the inventory on file for your property at the Webster Assessment Office.

Data verification is the first step in placing an accurate value on your property. The best valuation results will be derived from accurate inventory. Correcting your inventory before the valuation process is critical to ensuring the conversations about your value are about your property's value, not about the data. Visit our revaluation project page and select 'Verify Property Data' on the menu ribbon to get started.

Leaf collection is weather-dependent. Visit our website to look up the Zone map and find updates on where Highway crews will be!



2026 WEBSTER BUDGET

The Town of Webster's annual budget process involves a meticulous review of the finances to ensure Town services are being delivered to our community in a responsible manner. As in the recent past the 2026 budget underscores the Town of Webster's commitment to investing in infrastructure, supporting economic growth, and funding quality-of-life services. Providing top-notch services to the taxpayers is a priority which truly makes the Town of Webster a place where life is worth living.

Protecting Taxpayers

The Town of Webster works diligently to ensure that taxpayer dollars are being used responsibly to fund necessary expenditures and plan for the future. The 2026 budget protects taxpayers by remaining under the New York State tax cap.

There is a slight rise in the Town tax rate, with a net increase of \$0.13 from \$5.39 to \$5.52. Overall, the tax rate has remained relatively stable since 2020. Taxpayers will also see that there is an increase of \$5.70 in sewer rent charges, from \$252.73 to \$258.43.

As Supervisor Flaherty mentioned in his budget message, this means that the aggregate tax bill for an average house (assessed value of \$178,000) outside of the Village of Webster will increase 2.4%.

Town Tax Rate (per \$1,000 assessed value)




Fig. 1: The Town's tax rate has remained relatively stable across the past seven budget years.








Fig. 4 (left): The Town of Webster's anticipated major revenues for 2026.

Investing in Infrastructure

Timely investments in infrastructure equate to long-term cost savings. The 2026 Budget contains significant investments within our Town for maintenance and improvements to our Wastewater Treatment Plant, provisions for equipment to maintain town roads, construction of the new highway building, and park improvements.

The 2026 budget also includes an additional investment of \$400,000 into the Sewer Capital Reserve. This is significant, as this fund will support future sewer plant repairs and asset renewal.

Supporting Economic Growth

Economic growth and investing in our community continue to be a top priority for the Town of Webster. This can be seen in many aspects of our town government which is supported by the 2026 budget.

The upgrades to the Wastewater Treatment Plant to transform it into a Water Resource Recovery Facility is already generating significant revenue that will continue to grow in the future. This will

have a substantial impact on taxpayers' wallets. These upgrades also foster an environment that will continue to attract businesses to our community.

The 2026 budget also supports community planning initiatives like the update of the Town of Webster's Comprehensive Plan. This initiative is critical to establishing the vision for the future of Webster.

Funding Quality of Life Services

The Town of Webster is dedicated to delivering high quality services to our community. Throughout Town, residents and visitors can be found enjoying these offerings and amenities through our town parks, recreation programming, library programs, and services like the fall leaf pick up or material delivery/pick up through the Highway Department. The 2026 budget continues to fund and expand these beloved and relied upon amenities.

From delivering services to fostering economic growth to investing in infrastructure, the Town of Webster's 2026 budget supports residents and has the best interests of taxpayers in mind.

THE WOMEN'S CLUB OF WEBSTER

Celebrating Sixty Years in Town

For sixty years, the Women's Club of Webster has been a steadfast and community-driven presence that promotes the most vital aims of the Town of Webster. It started with five women fueled by a call to service and quickly grew into something bigger. The Women's Club became official on June 15, 1965. By September of that year, they hosted twenty-seven members at their first meeting. Their founders — Beverly Ashcroft, Ruth Jacque, Betty Picard, Marjorie Spear, and Nancy Thomas — recognized the importance of "friendship through service." These words became their foundation.

Today, those words live on as the group's timeless motto. The Women's Club has built upon that original foundation, now boasting about seventy members of all ages and backgrounds. Each one of them shares a collective passion for involvement and charity. It is from that drive that we see the sincere impact of their work.

Volunteerism from members is an essential aspect of the Women's Club. Each year, more than a dozen local

agencies count themselves among the beneficiaries of their volunteer hours and efforts. Recognizable charitable and educational pillars of our Town and beyond, including the Webster Public Library, the Webster Museum, Webster Community Chest, Hope House, Challenger Miracle Field, the YMCA, and many more, are included in the list.



The cultural, civic, educational, and social causes of Webster and Monroe County receive financial support from the Women's Club annually through three major fundraisers. They include a card party, a holiday cookie sale at the Webster Public Library, and a fashion show. So much success has

come from these fundraisers that the Club has donated more than \$37,000 to local non-profit organizations in the past five years alone. Participation in other service projects also contributes to the group's lengthy resume of selflessness. Chief among those projects is providing cookies for two Red Cross blood drives, food and toiletry donations from members to benefit Webster Hope, 50/50 raffles to benefit the Veterans Outreach Center, and other community projects like making cards for service members.

An impact on this scale does not occur by happenstance, however. It takes effort and, of course, friendship. Social events like luncheon meetings, held on the third Thursday of each month, and monthly card parties keep the group well-organized and connected. Dedication to kinship culminated in a celebration of its 60th anniversary on July 23, 2025. Over 100 attendees discussed the continued influence of the Women's Club, visited with past and current members, and conversed with representatives of some of the numerous local organizations that receive the Club's support.







ECONOMIC VITALITY IN WEBSTER

Progress on the Xerox campus

On August 19, Governor Kathy Hochul announced that the Webster Economic Alliance (WEDA) is receiving \$9.8 million grant through Empire State Development's (ESD) FAST NY Shovel-Ready Grant program. The Webster Town Board authorized the application for this grant in late March, and the grant application was submitted for in early April 2025.

This program provides grants for pre-development activities and infrastructure investments to develop sites to attract many eligible industries. The submitted application was through FAST NY's Track C, specific to infrastructure improvements. Through this track, grants are awarded to improve the shovel-readiness of existing, mature sites by funding infrastructure improvements such as water, sewer, transportation, electricity, gas, and other capital-eligible site improvement costs.

The grant funding will be used to make significant improvements in the area of the Xerox campus and surrounding, including improvements to the roads that make up the skeleton of the campus (Orchard, Panama, and Mitcheldean), extension of Chiyoda Drive and Boulter Industrial Parkway, upgrades to the sanitary sewer conveyance pipe near Basket Road and Salt Road, and provide electrical engineering master planning for future or eventual electric power

upgrades to the Xerox campus. This process will pave the way for Xerox to sell off acreage in subdividable parcels that can be developed into sites for large businesses to locate their facilities. This project maximizes the almost 300 acres of property in that area for development.

From here, the Town of Webster will continue working with WEDA and the Village of Webster within WEDA's agreement with ESD. WEDA will serve as the administrator of the grant, working collaboratively with the Town and Village to implement their respective aspects of the project.

In concert with this grant, Xerox has applied to the Village of Webster and Town of Webster Governments to move municipal lines on the campus. These moves will make sure that Village/Town line borders do not go through the middle of a subdividable 20, 40, 80+ acre parcel Xerox seeks to sell off. This municipal line movement will result in the Village picking up approximately twenty-five acres on the West campus (land south of Chiyoda Drive and the Webster Recreation Center) and the Town picking up approximately twenty-five acres east of Phillips Road.

The tentative plan is to have a joint Village Board of Trustees and Town

Board member public hearing on Tuesday, October 21, at the Village Board Room. Resolutions that will be considered at various Village and Town board meetings over the next month will set this public hearing.

Due to a specific Village law, 18-1804, a referendum vote of the approximately 3,300 registered voters who live in the Village of Webster has been tentatively scheduled for Tuesday, December 16. This vote would be for the Village voter to "OK" the reduction of Village land by the twenty-five acres that will be given to the Town East of Phillips Road. Critical to the Village voter decision on this are the two following things: Understanding this is part of a big plan that also has the Village obtaining twenty-five acres west of Phillips Road, and that maximum voter turnout at the December 16 vote is desirable.

This project is a milestone in what will continue to be economic opportunity and growth for the Town of Webster. The Town of Webster looks forward to seeing the area in the northeast portion of Town develop. We are fortunate to have a great partner in WEDA as the Town of Webster continues to foster economic vitality and make our community a place where life is worth living.
